REEB'S 2019 DREAM DOOR GIVEAWAY - OFFICIAL RULES

- 1. Official Rules** – These are the Official Rules of **Reeb's 2019 Dream Door Giveaway** (the "Sweepstakes")
- 2. NO PURCHASE NECESSARY TO ENTER OR WIN** – No purchase or payment is required to participate. Purchases and payments will not increase your chances of winning. You are not required to submit to any sales promotion efforts to participate.
- 3. Sponsorship** – The Sweepstakes' sponsor is Reeb Millwork Corporation of Maryland ("Reeb") located at 1315 Goldsboro Road, Barclay, Maryland, 21607. Reeb will conduct the Sweepstakes substantially as described in these Official Rules. Any reference to third parties herein is not intended to imply or otherwise create a sponsorship or affiliation with this Sweepstakes by those third parties.
- 4. Eligibility** – The Sweepstakes is open to all natural persons who are legal residents of the town of Barclay, located in Queen Anne's County, Maryland, who are at least the age of majority in Maryland. In order to receive a prize in this Sweepstakes, the winner must be a homeowner or obtain the written permission of a homeowner of a residential property located within Barclay. The prize must be deliverable to and installed at a residential property in Barclay, Maryland. The Sweepstakes is subject to all applicable federal, state, and local laws and regulations and is void where prohibited by law. Winners of any prizes that amount to or exceed Six Hundred Dollars (\$600.00) must also provide necessary information in order for Reeb to prepare an IRS 1099 form. Failure to satisfy any of these requirements may result in disqualification, in which case Reeb will randomly draw a different winner until all requirements are met.

Reeb and its respective affiliates, subsidiaries, successors, assigns, agents, representatives, officers, directors, shareholders, and employees, and any entity involved in the development, production, implementation, administration, judging or fulfillment of the Sweepstakes, including without limitation, the immediate family members of such individuals, are not eligible to participate. Winners, immediate family, and other household members of prior Reeb Dream Door Giveaways are not eligible to win and will be disqualified.

- 5. Entry Period** – Entries for the Sweepstakes may be submitted from 3:30 p.m. until 6:30 p.m. on September 6, 2019 (the "Entry Period"). A winner's name will be drawn at random at 6:45 p.m.
- 6. How to Enter** – Reeb will be hosting an open house event on September 6, 2019, from 3:30 p.m. until 7:00 p.m. at 1315 Goldsboro Road, Barclay, MD 21607 (the "Open House"). During the Entry Period at the Open House, entrants can fill out an entry form provided by Reeb and submit the entry form to a Reeb employee overseeing the event. All entries become the property of Reeb and none will be acknowledged or returned.

- 7. Limitation on Entry** – Limit of one (1) entry per person. No third party entry or entry through any sweepstakes service is permitted. Anyone who attempts or otherwise encourages the entry of multiple or false contact information under multiple identities or uses any devices or artifice to enter or encourage multiple or false entries, as determined by Reeb, will be disqualified.
- 8. Prize Options** – One (1) randomly chosen winner’s name will be drawn. The winner will be awarded one (1) of the following prize options that corresponds to their existing door unit (i.e., a winner with a single door unit will receive the single door unit prize, a winner with a single door with sidelite will receive the single door with sidelite prize, etc.):
- (1) Single Door Unit Option (estimated retail value \$1,100.00) – a Therma-Tru Smooth-Star S210, S296, or S118 door; 6-9/16” On-Guard Primed Jambs; adjustable composite sill; standard hinges; bronze weather strip; On-Guard composite brickmould; painted by Reeb Finish; or
 - (2) Single Door with Sidelite Option (estimated retail value \$2,200.00) – a Therma-Tru Smooth-Star S210, S296, or S118 door; a Therma-Tru Smooth-Star S210SL or S100SL sidelite; 6-9/16” On-Guard primed jambs; adjustable composite sill; standard hinges; bronze weather strip; On-Guard composite brickmould; painted by Reeb Finish; or
 - (3) Single Door with Double Sidelite Option (estimated retail value \$3,300.00) - a Therma-Tru Smooth-Star S210, S296, or S118 door; two (2) Therma-Tru Smooth-Star S210SL or S100SL sidelite; 6-9/16” On-Guard primed jambs; adjustable composite sill; standard hinges; bronze weather strip; On-Guard composite brickmould; painted by Reeb Finish.

Regardless of which prize option is chosen, the winner will also receive free installation of the chosen prize at his or her residence located in the town of Barclay (estimated retail value of \$400.00). Prior to installation, Reeb will need to conduct measurements at the location where the prize will be installed. Reeb will deliver and install the applicable prize option within five (5) weeks of the announcement of the winner, after scheduling a time with the homeowner, and subject to change based on the homeowner’s availability.

- 9. Non-transferable, No Substitutions, and No Equivalent Cash Value** – All prizes are non-transferable, and no substitution or cash equivalent will be provided. Winner is responsible for federal, state, and local taxes, if applicable. Reeb will issue an IRS 1099 form for a winner who wins a prize valued at Six Hundred Dollars (\$600.00) or more. The failure to provide adequate information for Reeb to complete an IRS 1099 form may result in disqualification and forfeiture of any winnings. The prizes and installation are subject to the manufacturer’s warranty, which Reeb adopts, and the Reeb Field Service Policy. In the event of a product shortage, force majeure, discontinued product lines, or any other legal or factual impossibility, Reeb reserves the right to substitute a prize of equal or greater retail value to the prizes set forth in these Official Rules, in its sole discretion.

10. Drawing – The winner will be selected in a random drawing from among all eligible entries collected during the Entry Period. The drawing will take place at the Open House at the time specified above. The drawing will be conducted by Reeb, whose decisions and interpretations on all matters relating to the Sweepstakes and these Official Rules are final and binding in all respects. Reeb reserves the right to disqualify any entrant or winner and may refuse to award a prize to a person who is not eligible or has violated a rule, gained an unfair advantage in the Sweepstakes, or otherwise won by using fraudulent or deceptive means. If the winner is found ineligible or not in compliance with Sweepstakes rules, the winner will be disqualified and an alternate winner will be awarded the prize in a separate random drawing, to be conducted by Reeb as soon as reasonably practicable.

11. Odds of Winning – The odds of winning will depend on the number of eligible entries received. Each entrant is limited to one entry, so an individual's odds of winning will be one (1) divided by the number of total entries received.

12. Penalties and Violations – Any person or entity, whether or not an entrant, who attempts to damage, destroy, tamper with or vandalize Reeb's website, any mobile applications or social networking site, or the entry process, or otherwise interferes with or undermines the legitimate operation of the Sweepstakes may be in violation of civil and criminal laws. Reeb reserves the right to seek damages and diligently pursue all remedies against any such person or entity to the fullest extent permitted by law.

13. General Terms – By participating in this Sweepstakes, you promise to abide by the Official Rules and decisions of Reeb, which will be final and binding in all respects. Reeb reserves the right, at its sole discretion, to refuse, disqualify or withdraw any entry at any time. Reeb will not be responsible for any injury, damage, or loss of any kind arising from or related to your participation in the Sweepstakes.

14. Existing Damage and Decoration – Reeb is not responsible for the repair or remediation of any existing damage, defects, or other potential harms at the winner's property. The failure of the winner to repair or remediate any pre-existing damage defects, or other potential harms may result in the waiver of coverage under the applicable manufacturer's warranty and/or Reeb Field Service Policy.

As part of the installation, Reeb will not be responsible to replace any decorative trim or moulding that may need to be removed in order for the installation of the prize. Reeb will attempt to reinstall any existing locking mechanism, but winner may need to replace the locking mechanism if it is incompatible or damaged.

15. Release and Hold Harmless – YOU AGREE TO RELEASE, DISCHARGE, AND HOLD HARMLESS REEB, ITS AFFILIATES, SUBSIDIARIES, EMPLOYEES, OFFICERS, DIRECTORS, AGENTS, AND ASSIGNS

FROM AND AGAINST ANY OR ALL CLAIMS, LOSSES, INJURIES, OR DAMAGES RESULTING FROM YOUR PARTICIPATION IN THIS SWEEPSTAKES.

16. Governing Law, Jurisdiction, Class Action Waiver, and Arbitration - Any controversy or claim arising from or relating to (1) the Sweepstakes, (2) the awarding or redemption of any prize, and/or (3) the determination of the scope or applicability of these Official Rules or their enforcement or interpretation shall be governed by and construed in accordance with the substantive laws of the state of Maryland, without regard to its conflicts of law principles. Any controversy or claim arising out of or relating to this agreement, its enforcement, interpretation, or arbitration requirements shall be submitted to final and binding private arbitration, to be held in Queen Anne's County, Maryland, before a panel of three (3) arbitrators. The arbitrators shall be selected by mutual agreement of Reeb and the entrant or entrants bringing forth the controversy or claim (collectively, the "Parties") or, if the Parties cannot agree, then by striking from a list of arbitrators supplied by the American Arbitration Association. The Parties agree any arbitration will be confidential and closed to the general public. The arbitrators shall issue a written opinion stating the essential findings and conclusions upon which the arbitrator's award is based. The Parties will share equally in payment of the arbitrator's fees and arbitration expenses and any other costs unique to the arbitration hearing (recognizing that each side bears its own deposition, witness, expert and attorneys' fees and other expenses). Each entrant agrees to resolve his or her claims individually, exclusively by arbitration, and waives any right to create, join, or otherwise participate in a class action. Each entrant further agrees that any damages in arbitration shall be limited to actual out-of-pocket costs incurred, including costs associated with participating in the Sweepstakes, and in no event will entrants be permitted to obtain attorneys' fees or other legal costs. Each entrant waives all punitive, incidental and consequential damages and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or increased. If any term of this section is deemed void, unenforceable or contrary to law, such term shall, but only to the extent necessary to bring this section within the requirements of law, be severed from the other terms of these Official Rules, and the remainder shall be given effect as if it had not included the severed term herein. THE PARTIES HEREBY WAIVE THEIR RIGHT TO JURY TRIAL WITH RESPECT TO ALL CLAIMS AND ISSUES ARISING OUT OF OR RELATING TO THIS AGREEMENT WHETHER SOUNDING IN CONTRACT OR TORT, AND INCLUDING ANY CLAIM FOR FRAUDULENT INDUCEMENT THEREOF.

With regards to any issues arising from or related to provided product defects or the installation of said products, the terms and conditions contained within the Reeb Field Service Policy and the applicable manufacturer's warranty, which Reeb adopts, shall apply and supersede any conflicting terms herein.
