Rider to Fiberglass Door Systems Limited Warranty

For Purchases Made on or After March 1, 2018.

This Limited Rider ("Rider") supplements the Therma-Tru® Fiberglass and Steel Door Systems Limited Warranty for Fiber-Classic®, Smooth-Star® and Pulse® Fiberglass Door System Products of Therma-Tru in effect on the purchase date ("Limited Warranty") only as provided herein. This Rider does not apply to wood or steel edge products including Classic-Craft®, Profiles™, steel and Traditions steel.

Except as modified by this Rider, all other terms of the Limited Warranty remain in full force and effect. Capitalized terms in this Rider have the same meaning as set forth in the Limited Warranty. 1. WHAT PRODUCTS THIS RIDER COVERS AND HOW LONG

Therma-Tru Corp.'s ("Seller's") fiberglass door slabs (excluding Classic-Craft) purchased on or after March 1, 2018, and originally installed and remaining in the original installation position and that have been manufactured with the Composite Edge feature ("Door Slab"). A genuine Therma-Tru Door Slab with Composite Edge can be identified by the part number located on top of the door.

Eligible Door Slabs will begin with one of the following options: "FCME", "FCOE", "FOOE", "SSE", "SSOE", "FE8", "FEF", "FER", "SE8", "SEF", or "SER" (example: FCME30060J-000129).

2. RIDER COVERAGE

Subject to the limitations below and in the Limited Warranty, the Door Slab is additionally warranted against rotting and / or delamination. This Rider covers the Door Slab only. This Rider does not cover any other components, including glass components.

3. RIDER WARRANTY PERIOD

LIFETIME LIMITED WARRANTY – RESIDENTIAL WARRANTY HOLDER (as provided in the Limited Warranty)

3-YEAR LIMITED WARRANTY – COMMERCIAL/MULTI-RESIDENT WARRANTY HOLDER (as provided in the Limited Warranty)

4. THIS RIDER'S EXCLUSIVE REMEDY

If a non-conformity as described above occurs during the applicable Warranty Period, and a warranty claim is initiated during the Warranty Period, Seller will:

a) Repair or replace the Door Slab (color matching not guaranteed) and pay the reasonable labor costs and expenses up to \$300 per Door Slab occurrence to repair and replace the defective Door Slab and reinstall and refinish the replacement Door Slab or other materials removed, reinstalled or refinished in conjunction with such Door Slab repair or replacement (color matching not guaranteed), but only if the repair/replacement is performed by Seller's authorized designee or as Seller otherwise agrees in writing.

OR

b) In lieu of repairing or replacing the Door Slab as provided above, if in Seller's sole opinion, Door Slab repair or replacement is not commercially practical or reasonable or cannot timely be made, Seller may refund the Warranty Holder's purchase price (the lesser of the original Door Slab purchase price or the original catalog list price) plus pay the Warranty Holder the sum of \$300.

Except as modified by this Rider, repaired or replaced Door Slabs are warranted only on the same terms as set forth in the Limited Warranty and only for the remainder of the Warranty Holder's Warranty Period.

5. CLAIMS

Claims under this Rider must be initiated during the Warranty Period as indicated in the Limited Warranty.

6. LIMITATION OF LIABILITY, AND DISCLAIMER OF WARRANTIES

This Rider, read in conjunction with "THERMA-TRU FIBERGLASS AND STEEL DOOR SYSTEMS RESIDENTIAL LIMITED WARRANTY" for Fiber-Classic, Smooth-Star, and Pulse Fiberglass Door System Products, sets forth the Warranty Holder's sole and exclusive remedy for a Door Slab's non-conformity. In no case with Seller by liable to the Warranty Holder or any other person for any consequential, special, or indirect losses or damages of any kind. Without limiting the scope of the foregoing: THE LIMITED WARRANTY AND THIS RIDER ARE IN LIEU OF AND EXCLUDE ALL OTHER WARRANTIES NOT EXPRESSLY SET FORTH THEREIN, EXPRESS OR IMPLIED BY OPERATION OF LAW OR OTHERWISE, INCLUDING BUT NOT LIMITED TO ANY IMPLIED WARRANTIES OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE. TO THE EXTENT THAT ANY IMPLIED WARRANTIES MAY NONETHELESS EXIST BY OPERATION OF LAW, SUCH WARRANTIES ARE LIMITED TO THE DURATION PROVIDED BY LAW. IF THIS LIMITED WARRANTY IS DEEMED TO HAVE FAILED OF ITS ESSENTIAL PURPOSE, IN NO EVENT WILL THERMA-TRU'S ENTIRE LIABILITY EXCEED THE LESSER OF THE PRODUCT'S OR THE NON-CONFORMING COMPONENT'S PURCHASE PRICE.

For Door Slabs installed outside the USA or Canada, Therma-Tru disclaims application of this Rider and all warranties of the kind provided solely by this Rider, whether express or implied, by operation of law or otherwise, and any and all liability for resulting damages of the kind covered solely by this Rider.
